WHEREAS, said monies were not included in the adopted appropriations and estimated revenues for the FY 2016-17 Public Works and Planning, HOME Investment Fund Organization 1202; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2016-17 Public Works and Planning, HOME Investment Fund Organization 1202 as follows:

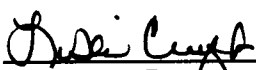
