#### AMENDMENT I TO AGREEMENT

THIS AMENDMENT I TO AGREEMENT, ("Amendment I"), is made this <a href="9th">9th</a> day of <a href="December">December</a>, 2025 ("Effective Date"), by and between the COUNTY OF FRESNO, a political subdivision of the State of California ("County"), and the City of Reedley ("City").

#### WITNESSETH

WHEREAS, the County has been designated as the sponsoring agency to administer and implement the Community Development Block Grant (CDBG) Program activities of the County, and its participating cities, in accordance with the provisions of Title I of the Housing and Community Development Act of 1974, as amended, and the laws of the State of California; and

WHEREAS, on September 10, 2024, the County and the City entered into Agreement 24-495 ("Agreement"), whereby \$424,530 in CDBG funds were made available to the City for the Reedley Rupert and Church Reconstruction Project No. 24571 ("Project"); and

WHEREAS, the City informed the County that the total estimated cost of the Project has increased from \$550,161 to \$553,984 due to increased construction costs; and

WHEREAS, the City is in need of \$129,454 in CDBG funding to complete the Project and reduce local financial contribution; and

WHEREAS, there is \$129,454 in CDBG funds that can be made available to the City for the Project this fiscal year; and

NOW THEREFORE, in consideration of their mutual promises as hereinafter set forth, the County and City agree to amend the Agreement as follows:

1. Page 1, Lines 14-21, are amended to read:

"WHEREAS, the City has estimated that the total cost of the Project is \$553,984, and the City has requested the sum of \$553,984 in CDBG funds be made available for the Project; and

WHEREAS, the County can provide \$553,984 in CDBG funds needed for the Project from the City's 2024-2025 CDBG allocation as approved by the Board in the 2024-2025 Annual Action Plan on June 18, 2024, and from the City's 2025-2026 CDBG allocation as approved by the Board in the 2025-2026 Annual Action Plan on August 5, 2025; and

1	WHEREAS, there is an additional \$129,454 in CDBG funds that may be made	de		
2	available to the City for the Project in Fiscal Year 2025-2026;			
3	WHEREAS, the Project is consistent with the objectives of the Fresno Cour	ıty
