WHEREAS, the Department of Social Services requires \$2,146,178 to meet expenditures associated with the Department's share of inventory findings from International Business Machines, Inc.; and

WHEREAS, the Department of Social Services ISD Organization 56108550 will receive \$2,146,178 as an Operating Transfer In from the Welfare Advance Fund Org 1120 and the Protective Services Subaccount Org 6210; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues of the FY 2015-16 Department of Social Services ISD Organization 56108550 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2015-16 Department of Social Services ISD Organization 56108550 as follows:


