RESOLUTION

WHEREAS, additional appropriations are required by the Alternate Indigent Defense (AID) Org 2875 to provide funding for increased alternate indigent defense claims and costs, including court-ordered claims for court-appointed attorneys and Public Defense Pilot Program-related services; and

WHEREAS, a portion of the increased appropriations will be offset by unanticipated refunds received in attorney court claim fees in FY 2025-26; and

WHEREAS, existing budgeted General Fund appropriations from Contingencies Org 8210 will provide additional support for increased costs and revenue shortfalls in AID Org 2875; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues of the FY 2025-26 Adopted Budget for AID Org 2875; and

WHEREAS, Government Code section 29130 provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer – Tax Collector is authorized to increase the appropriations in the FY 2025-26 for AID Org 2875 as follows:

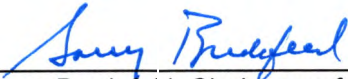

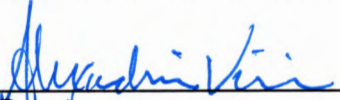
