WHEREAS, the Behavioral Health Org 5630 will have \$1,250,000 available for the Health and Wellness Center (HAWC) HVAC and reroofing projects ; and

WHEREAS, the DBH – Capital Projects Org 8859 will receive \$1,250,000 as an Operating Transfer In from the Behavioral Health Org 5630 for the HAWC HVAC and reroofing projects; and

WHEREAS, \$1,250,000 is not included in the FY 2018-19 adopted appropriations and estimated revenues for the DBH – Capital Projects Org 8859; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5 vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2018-19 Budget of the DBH – Capital Projects Org 8859 as follows:

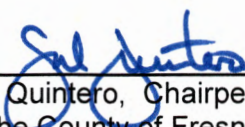

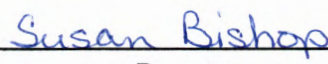
