CERTIFICATE OF TENTATIVE CANCELLATION

NOTICE IS HEREBY GIVEN:

By resolution dated October 11, 2016, the Board of Supervisors of the County of Fresno granted tentative approval of the petition by Eriksson LLC, for partial cancellation of Agricultural Land Conservation Contract (ALCC) No. 5204, which applies to the real property situated in the County of Fresno, State of California, and is more particularly described on the legal description attached as Exhibit "A", and made a part hereof, describing an approximately 40.20-acre parcel subject to cancellation.

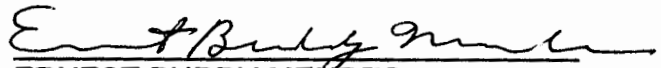
The above-referenced parcel encompasses the total of the real property subject to ALCC No. 5204.

A Certificate of Cancellation of the Contract shall be issued and recorded at such time as the following contingencies and conditions are satisfied:

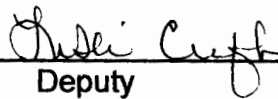
1. The landowner shall obtain the necessary land use approvals, including a Conditional Use Permit (CUP) to establish the proposed pistachio huller and processing facility on the subject property.

1 2. The applicant shall pay the Cancellation Fee in the amount of \$70,000
2 as determined by the County Assessor and certified by the Board of Supervisors for
3 issuance of a Certificate of Cancellation by the Board. If the Fee is not paid within one
4 year of the issuance of the Tentative Certificate of Cancellation, the Fee shall be
5 recomputed by the Assessor and certified by the Board. The Cancellation Fee shall be
6 paid and a Certificate of Cancellation issued prior to commencement of the CUP
7 including issuance of any grading or construction permits.

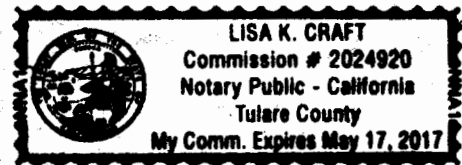


EXHIBIT A
