IN THE AMOUNT OF \$176,958)

WHEREAS, the Health and Welfare Trust Organization 5243 will receive an additional \$176,958 in unbudgeted revenues from the State of California for social services sales tax adjustments; and

WHEREAS, the \$176,958 is not included in the FY 2014-15 adopted appropriations and estimated revenues of the Health and Welfare Trust Organization 5243; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5 vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2014-15 budget of the Health and Welfare Trust Organization 5243 as follows:


