WHEREAS, on January 14, 2014 this Board approved an agreement with ViaTRON Systems, Inc. to provide document scanning and conversion services to image Assessor documents; and

WHEREAS, the agreement was in the amount of \$1,660,000 and, to date, the Assessor has paid expenses of \$901,091; and

WHEREAS, the Assessor requires an additional \$758,909 in appropriations for the balance of the agreement; and

WHEREAS, the Assessor-Recorder Organization 0420 will receive \$758,909 as an Operating Transfer In from the Assessor AB-818 Organization 1040 to offset the expenses of the imaging project (\$758,909); and

WHEREAS, said monies are not included in FY 2015-16 adopted appropriations and estimated revenues of the Assessor-Recorder Organization 0420; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths (4/5<sup>th</sup>) vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the FY 2015-16 appropriations in the Assessor-Recorder Organization 0420 as follows:






