RESOLUTION

WHEREAS, additional appropriations are required by the Alternate Indigent Defense (AID) Org 2875 to provide funding for increased alternate indigent defense claims and costs, including court-ordered claims for court-appointed attorneys; and

WHEREAS, four Year 4 Public Defense Pilot Program-related (PDPP) invoices were previously anticipated to be reimbursed with PDPP grant revenue, of which two invoices will be covered by available grant funds and the remaining two invoices, estimated at \$58,493, will not be reimbursed with grant revenue due to the earlier-than-anticipated exhaustion of available PDPP grant funds; and

WHEREAS, Approp for Contingencies Org 8210 includes appropriations available to fund unanticipated expenditures during the fiscal year; and

WHEREAS, said monies will be re-budgeted to the FY 2025-26 Adopted Budget for AID Org 2875; and

WHEREAS, Section 29130 of the Governmental Code provides for the re-budgeting of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer – Tax Collector is authorized to decrease the appropriations in the FY 2025-26 for Approp for Contingencies Org 8210 as follows:

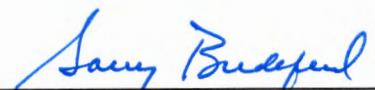
