WHEREAS, the Department of Public Health Organization 5620 requires \$300,000 to meet expenditures associated with the Counties Integrated Data Sharing (IDS) Initiative; and

WHEREAS, this project was approved by the County’s Ad-Hoc Committee, and is eligible under one of the four categories of eligibility under the Coronavirus State and Local Fiscal Recovery Funds (SLFRF) Program under the American Rescue Plan Act of 2021; and

WHEREAS, said additional costs will be financed by public assistance funds provided through the American Rescue Plan Act – State Local Fiscal Recovery Fund; and

WHEREAS, said monies are not included in the FY 2022-23 adopted appropriations and estimated revenues of the Department of Public Health Organization 5620; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2022-23 Department of Public Health Organization 5620 as follows:


