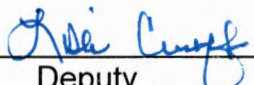

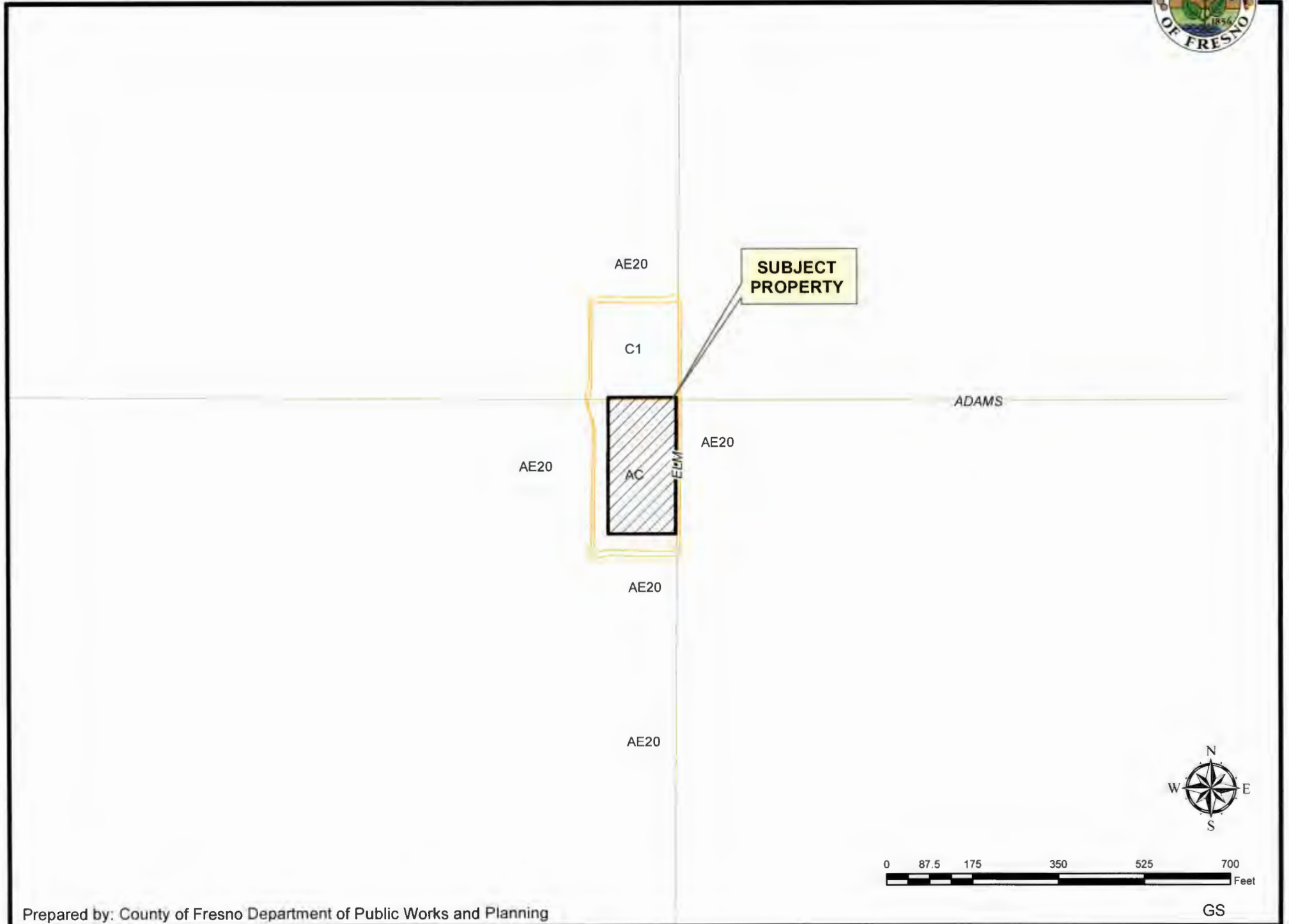

EXISTING ZONING MAP

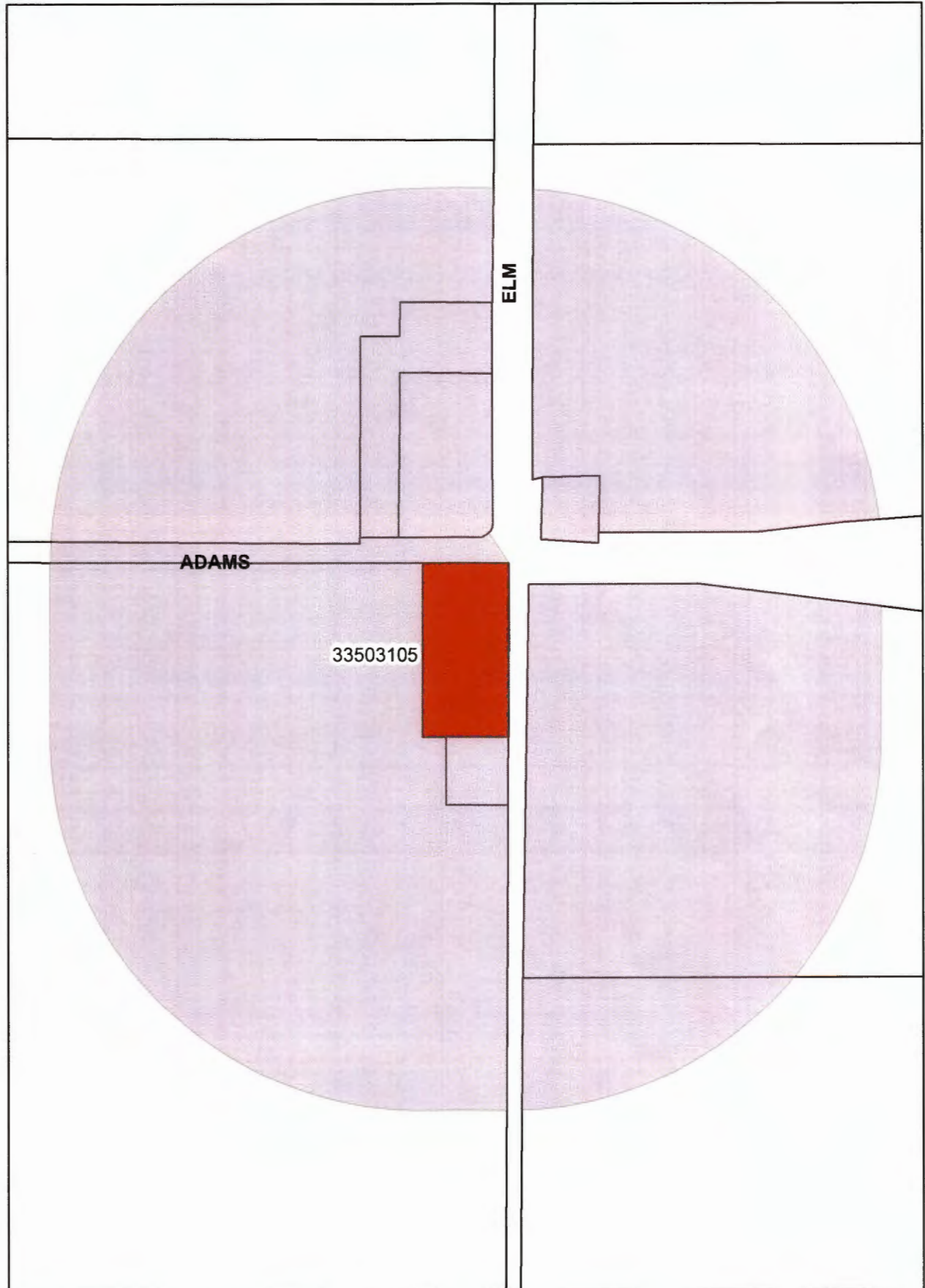

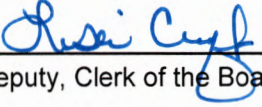
