AMENDMENT I TO AGREEMENT

THIS AMENDMENT I TO AGREEMENT, ("Amendment I"), is made this 21st day of October, 2025, ("Effective Date"), by and between the COUNTY OF FRESNO, a political subdivision of the State of California ("County"), and the RIVERDALE MEMORIAL DISTRICT ("District").

WITNESSETH

WHEREAS, the County has been designated as the sponsoring agency to administer and implement the Community Development Block Grant (CDBG) Program activities of the County, and its participating cities, in accordance with the provisions of Title I of the Housing and Community Development Act of 1974, as amended, and the laws of the State of California; and

WHEREAS, on July 13, 2021, the County and the District entered into Agreement 21-266 ("Agreement"), whereby \$250,000 in CDBG funds were made available to the District for the Riverdale Memorial Hall Improvements, Project No. 20591 ("Project"); and

WHEREAS, the District informed the County that the total estimated cost of the Project has increased from \$250,000 to \$450,000 due to increased construction costs; and

WHEREAS, the District is in need of \$200,000 in CDBG funding to complete the Project; and

WHEREAS, there is \$200,000 in CDBG funds that can be made available to the District for the Project this fiscal year; and

WHEREAS, the District has requested a modification to the Time of Performance for the Project, due to delays experienced in preparation of the Project plans and specifications.

NOW THEREFORE, in consideration of their mutual promises as hereinafter set forth, the County and District agree to amend the Agreement as follows:

1. Page 1, Lines 15-21, are amended to read:

"WHEREAS, the District has estimated that the total cost of the Project is \$450,000, and the District has requested the sum of \$450,000 from the County's allocation of CDBG funds; and

WHEREAS, the County Board of Supervisors, at a public hearing conducted on

1 County and District agree that this Amendment I is sufficient to amend the Agreement, and 2 that upon execution of this Amendment I, the Agreement and this Amendment I together shall be considered the Agreement. 3 The Agreement, as hereby amended, is ratified and continued.
