WHEREAS, the State has identified funding to reimburse counties for implementation of the
Voter's Choice Act; and

WHEREAS, additional funding is needed to pay for implementation of the Act including
conducting required outreach; and

WHEREAS, the State has committed to reimburse counties for purchase of required outreach;
and

WHEREAS, said monies were not included in the FY 2021-22 adopted appropriations and
estimated revenues of the County Clerk-Elections Organization 2850; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these
funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is
authorized to increase the appropriations in the FY 2021-22 County Clerk -Elections Organization
2850 as follows:


