20 WHEREAS, said monies were not included in the FY 2021-22 adopted appropriations and
21 estimated revenues of the County Clerk-Elections Organization 2850; and

22 WHEREAS, Section 29130 of the Government Code provides for the appropriation of these
23 funds by a four-fifths vote of the Board of Supervisors;

24 NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is
25 authorized to increase the appropriations in the FY 2021-22 County Clerk -Elections Organization


