cancel any unused appropriations and estimated revenues;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector
is authorized to decrease the appropriations in the FY 2017-18 Public Works & Planning-Grants

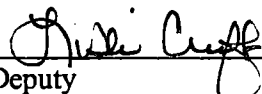
