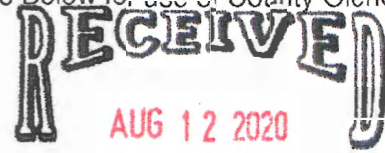

PUBLICATION OF SUMMARY OF PROPOSED ORDINANCE BOARD OF SUPERVISORS COUNTY OF FRESNO

The Fresno County Board of Supervisors is giving notice that at their regularly scheduled meeting on August 18, 2020 at 9:00 a.m., or as soon thereafter as the matter may be heard, at the Fresno County Hall of Records, Board of Supervisors Chambers, 3rd Floor, 2281 Tulare Street, Fresno, California, they will consider adoption of the ordinance summarized below.

SUMMARY OF PROPOSED ORDINANCE

The Ordinance will amend the Ordinance Code Pertaining to Election Contributions. The Ordinance adopted new section 2.62.040 of the Fresno County Ordinance Code to limit campaign contributions to candidates for County elective office from all persons to \$30,000 per election. The Ordinance also amended section 2.62.055 to include making it a misdemeanor to violate the provisions of section 2.62.040 and providing for penalties of a fine up to \$1,000 or imprisonment for up to six months, or both.
