5	WHEREAS, Project First Step was established in 2005 in Fresno County through a collaborative
6	partnership among the Marjaree Mason Center, the Pro Bono Services Committee of the Fresno County Bar Association, Fresno County Women Lawyers, and Central California Legal Services (CCLS). Since then, the Project First Step initiative has grown to include additional partners, including Centro La Familia Advocacy Services and the California Hmong Advocacy Network – Building Our Future, with the goal of providing free legal representation to domestic violence survivors in their efforts to obtain permanent restraining orders; and

9 10	WHEREAS, domestic violence is a profound and pervasive issue affecting individuals, families, and communities across California, and the legal system plays a vital role in ensuring safety, justice, and long-term protection for survivors; and
11 12	WHEREAS, survivors of domestic violence who have access to legal representation are significantly more likely to secure permanent restraining orders, obtain appropriate and protective custody orders for their children, and are less likely to be revictimized, while also experiencing reduced trauma and improved economic well-being; and
13 14	WHEREAS, Project First Step connects survivors who have already obtained temporary restraining orders with qualified pro bono attorneys for the limited legal purpose of seeking a permanent restraining order, with referrals coordinated through CCLS' Family Law team and its network of domestic violence crisis center partners; and
15 16 17	WHEREAS, pro bono attorneys participating in Project First Step initiative receive ongoing legal support and mentorship from CCLS' experienced Family Law advocates and the CCLS Pro Bono Program team, and the pro bono attorneys are protected under primary malpractice coverage provided by CCLS, whereby representation is grounded in a Limited Scope of Retainer Agreement and corresponding Notice of Limited Scope Representation, allowing attorneys to serve with clarity, confidence, and impact; and
18 19	WHEREAS, for the past two decades, Project First Step has brought representation and justice for victims of domestic violence and made life-saving differences in the lives of countless survivors who otherwise are unable to afford legal representation to find safety and protection under the law; and
20	WHEREAS, in 2025, Project First Step celebrates its 20th Anniversary, with a new chapter in the fight for justice, safety, and dignity with the extension of critical services to more communities in Tulare and Kings Counties by adding new coalition partners including Tulare County Bar Association, Family Services of Tulare County, Central California Family Crisis Center, Kings Community Action Organization, and Central California Legal Services.
