WHEREAS, the Department of Social Services - Aid to Adoptions Organization 6415 requires an additional \$176,958 in appropriations in order to make mandated assistance payments; and

WHEREAS, the Department of Social Services - Aid to Adoptions Organization 6415 will receive an additional \$176,958 from the Health and Welfare Trust Organization 5243 due to sales tax adjustments; and

WHEREAS, said monies are not included in the FY 2014-15 adopted appropriations and estimated revenues of the Department of Social Services - Aid to Adoptions Organization 6415; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5 vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2014-15 budget of the Department of Social Service - Aid to Adoptions Organization 6415 as follows:


