RESOLUTION

WHEREAS, the laws of the State of California require Fresno County to adopt and maintain a General Plan to guide the long-term development of the County, pursuant to Government Code, Section 65300 et seq.; and

WHEREAS, Government Code, Section 65400(a)(2) requires that an annual report be prepared on the progress in the implementation of the General Plan, and an annual progress on implementation of the County's Housing Element, including meeting its share of Regional Housing Needs Allocation (RHNA); and

WHEREAS, the Planning Commission conducted a duly noticed public hearing on the 2024 General Plan Annual Progress Report (APR) on March 13, 2025; and

WHEREAS, the Planning Commission received staff's presentation on the 2024 APR and public testimony and recommended that the Board accept the 2024 APR including the proposed modifications to the Administration and Implementation Tables, the corrections noted in the staff presentation and authorize staff to pursue other amendments to the General Plan as described in the staff report; and directed the Clerk to prepare a Resolution reflecting the Commission's action; and

WHEREAS, the Board of Supervisors considered the 2024 APR at a duly noticed public hearing on March 25, 2025.

NOW, THEREFORE IT IS HEREBY RESOLVED that the Board of Supervisors hereby adopts this Resolution accepting the 2024 APR and authorizes the Department of Public Works and Planning (Department) to submit the 2024 APR to the State Department of Housing and Community Development and the Governor's Office of Land Use and Climate Innovation. Authorizes the Department to make proposed

1 modifications to the General Plan Administration and Implementation Tables, and
2 authorize staff to pursue other amendments to the General Plan.
