9 WHEREAS, the County of Fresno Board of Supervisors has designated the Probation
10 Department as the implementing agency in Fresno County to provide comprehensive services to victims
11 and/or witnesses of all types of crime through the Crime Victim Assistance Center, pursuant to California
12 Penal Code § 13835; and

13 WHEREAS, the Board of Supervisors of the County of Fresno desires to undertake a certain
14 project designated Victim/Witness Assistance (VW) Program, to be funded in part from funds made
15 available through the Governor's Office of Emergency Services (Cal OES), with the County having
16 oversight and responsibility.

17 NOW, THEREFORE, BE IT RESOLVED that the Chairman of the Fresno County Board of
18 Supervisors is authorized on behalf of the Applicant County of Fresno (retroactive to October 1, 2019),
19 to submit the previously submitted Application for the Victim/Witness Assistance (VW) Program to
20 Cal OES, and is further authorized to execute, on behalf of the County of Fresno, the attached Grant
21 Subaward and related Cal OES required documents, including any extensions or amendments thereto,
22 subject to approval by County Counsel and the County Auditor, not to exceed \$1,659,359.

23 BE IT FURTHER RESOLVED that the County of Fresno agrees to provide all matching funds
24 required for the Victim/Witness Assistance (VW) Program, including any extension or amendment
25 thereof, and agrees to comply with the rules and regulations of Cal OES.

26 BE IT FURTHER RESOLVED that grant funds received hereunder shall not be used to supplant
27 expenditures controlled by this body.


