

**FIRST AMENDMENT TO  
MASTER DUAL JURISDICTION COOPERATIVE AGREEMENT**

This First Amendment to the Master Dual Jurisdiction Cooperative Agreement (Cooperative Agreement) is made and entered into this 9th day of December, 2025, by and between the City of Reedley, a California municipal corporation (City), and the County of Fresno, a political subdivision of the State of California (County) (collectively, the Parties) with respect to Projects performed cooperatively by the Parties.

**RECITALS**

WHEREAS, the Parties entered into the Cooperative Agreement on January 7, 2020; and

WHEREAS, the term of the Cooperative Agreement expires December 31, 2025, and allows for the term of the Cooperative Agreement to be extended by mutual agreement of the Parties; and

WHEREAS, the Parties desire to extend the term of the Cooperative Agreement to December 31, 2030.

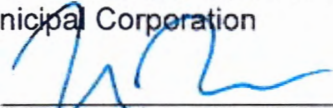
NOW, THEREFORE, in consideration of the mutual agreement, the City and County agree as follows:

**AGREEMENT**

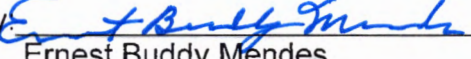
1. The term of the Cooperative Agreement shall be extended through December 31, 2030.

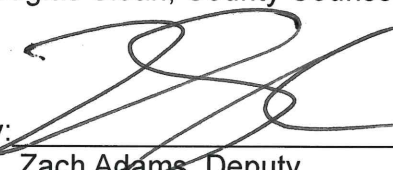
