WHEREAS, the County Buildings Org 0131 requires \$9,500,000 for purchase of property located at 5555 E Olive Ave, Fresno, CA 93727; and

WHEREAS, the DBH Org 5630 will have \$9,500,000 available for purchase of property; and

WHEREAS, the County Buildings Org 0131 will receive \$9,500,000 as an Operating Transfer In from the DBH Org 5630 to purchase the property; and

WHEREAS, \$9,500,000 is not included in the FY 2020-21 adopted appropriations and estimated revenues for the County Buildings Org 0131; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5 vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2020-21 Budget of the County Buildings Org 0131 as follows:
