WHEREAS, the Local Revenue Fund 2011 Fund 0271, Protective Services Subaccount Org 6210 received additional revenues of \$863,961 from State of California for unbudgeted Sales Tax General Growth revenues to meet unanticipated expenses associated with the Aid to Adoptions Org 6415; and

WHEREAS, said monies were not included in the FY 2023-24 adopted appropriations of the Protective Services Subaccount Org 6210; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2023-24 Protective Services Subaccount Org 6210 as follows:
