RESOLUTION

WHEREAS, pursuant to Public Resources Code sections 48000 et seq., 14581, and 42023.1(g), the Department of Resources Recycling and Recovery (CalRecycle) has established various payment programs to make payments to qualifying jurisdictions; and

WHEREAS, in furtherance of this authority CalRecycle is required to establish procedures governing administration of the payment programs; and

WHEREAS, the various payment programs allow for both individual and regional participation; and

WHEREAS, CalRecycle’s procedures for administering payment programs require, among other things, an applicant’s governing body to declare by resolution certain authorizations related to the administration of the payment programs.

NOW, THEREFORE, BE IT RESOLVED that the BOARD OF SUPERVISORS OF THE COUNTY OF FRESNO (BOARD) hereby authorizes submittal of applications for the various payment programs, identified in Exhibit “A”, as follows:

1. EITHER on behalf of itself as Regional Lead Participant and designated participating jurisdictions, attached hereto as Exhibit “B”, OR
2. As an individual applicant of the payment program(s); and

BE IT FURTHER RESOLVED that the CHAIRMAN OF THE BOARD OF SUPERVISORS (CHAIRMAN), or his/her designee, and the DIRECTOR OF PUBLIC WORKS AND PLANNING (DIRECTOR), or his/her designee, are hereby authorized as Signature Authority to execute all documents necessary to implement and secure payment; and

BE IT FURTHER RESOLVED that either the CHAIRMAN or the DIRECTOR, or the respective designee or either of them, each of whom having been designated and authorized as

1 Signature Authority as provided hereinabove, are hereby authorized to revise the list of  
2 participating jurisdictions as necessary with each yearly application; and

3 BE IT FURTHER RESOLVED that this Resolution superseded all prior resolutions  
4 relating to the subject matter hereof and that this Resolution is and shall be effective for a period  
5 of five (5) years from its date of adoption; and

6 The foregoing Resolution was passed by the following vote of the Board of Supervisors


