This experience has given him a unique 14 understanding of the Public Works and Planning Department, including overseeing County projects and 15 a vast knowledge of a variety of construction issues that could arise on projects, and: 16 WHEREAS, Government Code section 7522.56 requires a one-hundred eighty (180) day 17 separation period, as established by the California Public Employees' Pension Reform Act, unless the 18 employer's governing body finds and certifies the nature of the employment, and that the appointment 19 is necessary to fill a critically needed position before the one-hundred eighty (180) day separation 20 period has passed. 21 NOW, THEREFORE, BE IT RESOLVED, that the Fresno County Board of Supervisors hereby 22 adopts this Resolution to hire extra-help retiree William LaRue Goossen on an as-needed basis, 23 effective July 21, 2025, finding and certifying that the provisions of Government Code section 7522.56 24 requiring a one-hundred eighty (180) separation period for retired employees returning to employment 25 as extra-help are not applicable to Mr. Goossen, because of the nature of Mr. Goossen's employment 26 and his appointment is necessary to fill a critically-needed position before 180 days has passed 27 following the date of Mr. Goossen's retirement. 28 ///
