WHEREAS, William LaRue Goossen, retired as a Senior Engineering Technician effective March 29, 2025, at 5:00 p.m., and

WHEREAS, there are no current vacancies with the Construction Management division for Senior Engineering Technician, and;

WHEREAS, Mr. Goossen has an extensive background with over 27 years of experience in the field of Construction Management within the County of Fresno. This experience has given him a unique understanding of the Public Works and Planning Department, including overseeing County projects and a vast knowledge of a variety of construction issues that could arise on projects, and;

WHEREAS, Government Code section 7522.56 requires a one-hundred eighty (180) day separation period, as established by the California Public Employees' Pension Reform Act, unless the employer's governing body finds and certifies the nature of the employment, and that the appointment is necessary to fill a critically needed position before the one-hundred eighty (180) day separation period has passed.

NOW, THEREFORE, BE IT RESOLVED, that the Fresno County Board of Supervisors hereby adopts this Resolution to hire extra-help retiree William LaRue Goossen on an as-needed basis, effective July 21, 2025, finding and certifying that the provisions of Government Code section 7522.56 requiring a one-hundred eighty (180) separation period for retired employees returning to employment as extra-help are not applicable to Mr. Goossen, because of the nature of Mr. Goossen's employment and his appointment is necessary to fill a critically-needed position before 180 days has passed following the date of Mr. Goossen's retirement.
