The County Clerk - Elections office is required by California Election Code 3016.5 to implement a Remote Accessible Vote by Mail system by January 1, 2020. Democracy Live's Secure Select Remote Accessible Vote by Mail sytem is certified by the California Secretary of State to provide this service.

\$0.00 for the twenty four month period beginning 4/23/19. El Dorado County, on behalf of the DRAM Settlement Grant Consortium has received \$198,000.00 that will be paid to Democracy Live in two installments of \$99,000.00.
4. Identify the unique qualities and/or capabilities of the service(s) and/or product(s) that qualify this as a Suspension of Competition acquisition.  
Democracy Live, Inc. was selected by the DRAM Settlement Grant Consortium, of which Fresno County is a member, as the vendor to deploy a comprehensive Remote Accessible Vote by Mail system. Fresno County will be using Democracy Live's Secure Select Remote Accessible Vote by Mail system for any scheduled election during twenty four month period beginning 4/23/19. No other vendor has this proprietary system.

El Dorado County has accepted \$198,000.00 grant funds on behalf of the five Consortium members to pay for these twenty four months of service.
