
Subject: Applciation for Alcoholic Beverage License Off-Sale

To Whom It May Concern,


My wife and I are property owners in CSA-31, Shaver Lake, Fresno County, CA and are concerned with the continuing requests for licenses for alcoholic beverage sales in the Shaver Lake area. The year round population for Shaver Lake is approximately 600 at the last census and even with the large number of tourists during the summer the number of establishments selling Off-Sale is significant for the area and the floating population.

In addition, most of the current establishments having Off-Sale licenses are locally owned and operated which in this area where jobs are scarce means that the people are committed to providing a service year round. Neither of us feel that adding another Off-Sale establishment is in the best interest of the residents of the Shaver Lake Community and are therefore against the issuing of the license. Unfortunately, we will not be able to be at the Supervisor's Meeting but wanted our concerns noted for the records.
