3. What is the total cost of the acquisition? If an agreement, state the total cost of the initial term and the amounts for potential renewal terms.

The agreement is for five consecutive years with an option for termination in the Service Agreement. The total cost of the agreement is for \$785,000. The annual maximum for each year will be as follows: Year 1-2 - \$144,000, Year 3-4 - \$157,000, and Year 5 - \$183,000.

4. Identify the unique qualities and/or capabilities of the service(s) and/or product(s) that qualify this as a Suspension of Competition acquisition.

The Fresno County Sheriff's Office has had a beneficial professional partnership since 2015. We have an established relationship with Victoria Sanders, and are confident that her practice understands the unique stressors impacting law enforcement members and their families. This partnership requires a high degree of trust since billing is 100% confidential to protect the identity of our employees. After 10 years of partnership, our department has established the necessary trust required with Victoria Sanders - both administratively and clinically. Additionally, we want to continue the partnership with this vendor for the continuity of care of our employees.

  Law enforcement professionals experience highly stressful and traumatic incidents on a regular basis. These incidents have been known to have a negative impact on a person's mental health, physical health, and family life. Over time, these issues have an extremely devestating compound effect on our employees. Whenever possible, we seek to provide our employees with highly trained professionals and effective resources to aid them in fostering healthy coping mechanisms, discovering safe outlets for decompression, and maintaining skills to combat negative stressors as they arise in the future. Our experience with VMS has been positive in this regard. Our employees' consistent use of this contract with VMS is proof of its necessity to our organization.

We are committed to providing our employees with a local vendor that has the ability to meet in-person (not long distance over Zoom only). Two other separate local vendors have practices that specialize in law enforcement stressors, Dr. Erene Soliman and Dr. Jana Price-Sharps, however, both are contracted vendors for the County's pre-employment and compulsory psychological screening contract. We feel it would be a conflict of interest to use these vendors for dual purpose for our employee assistance program when they are separately evaluating our employees for hire and/or compulsory matters. Other large multi-staff clinics, such as the Resiliency Center, do not specialize in the law enforcement issues specific to our industry. The Sheriff's Office wants to keep the care with current patients consistent from VMS as they understand the unique stressors associated with law enforcement. The Sheriff's Office has no desire to transfer our employees' care to another vendor that does not

specialize in law enforcement or have an established relationship with them.
