- PERMITTEE agrees to indemnify and hold PERMITTOR harmless from any damage caused by PERMITTEE's 4. activities authorized by this permit. PERMITTEE agrees also to either reimburse PERMITTOR for any damage to PERMITTOR's roads and fences, or other property, occurring by reason of the exercise of rights granted herein, or to replace or restore said property.
- 5. This permit expires on December 31, 2022, but will be renewed automatically for one-year periods thereafter unless either party provides written notice to the other party of their intention to not renew the permit at least sixty (60) days prior to expiration of the extension period.
- PERMITTEE agrees to inform PERMITTOR's Department of Public Works and Planning when anybody plans to 6. be on PERMITTOR's property in relation to PERMITEE's activities authorized by this permit.
