RESOLUTION

WHEREAS, the Aid to Families with Dependent Children-Foster Care Org 6410 will receive \$7,025,306 as an Operating Transfer In from the Social Services Fund 0065, Subclass 17225, Welfare Advance Fund Org 1120 (\$1,785,463), the Local Health and Welfare Trust Fund 0135, Subclass 13046, 1991 Realign-Social Services Org 5246 (\$1,535,205), and the Protective Services Subaccount Org 6210 (\$3,704,638); and

WHEREAS, said monies were not included in the FY 2021-22 adopted appropriations and estimated revenues of the Aid to Families with Dependent Children-Foster Care Org 6410 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2021-22 Aid to Families with Dependent Children-Foster Care Org 6410 as follows:


