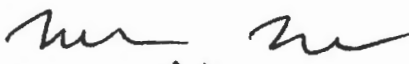
Hello Board of Supervisors,

If we were responsible for paying the water debt I don't know how we would be able to feed and cloth our children. It's been a difficult couple of years. We ~~manage~~ manage to pay our current water bill with effort and sacrifice. We would greatly appreciate if the county converted what is owe into a loan so that it can be forgiven. or if they use funds from ARPA to cover what is ~~not~~ owed. Hello,

I am writing because I live an hour away on the westside of Fresno county in a rural community. I have been a resident of this community for 18 years in El Porvenir. We need our roads to be rebuilt because there are areas in the community where the roads are uneven with no paved road and there are many cracks on it. We get temporary fixes but they have not lasted they deteriorate within a year or three. These roads might seemed they don't get used often use. But everyday depending on the season of the month vehicles come in and out for people that work in agriculture. These roads are used by several school buses that transport children on a daily basis. When it rains our road gets flooded because of the unevenness and there is no place for the water to run it needs to get pumped out. Our sidewalks we use are made of dirt where children don't use them on a rainy day to avoid getting muddy and wet. I ask that we be considered for this project because our community needs it for the amount of significant traffic that uses it daily and because we are far over due a new roadway. In all my years I have not seen one completely rebuilt road way in my community. And not so far from my community is cantua creek that also needs there roads updated as well because these both communities share the same characteristics and challenges and the only difference they share is the distance of 5 miles between the too.
