WHEREAS, on April 19, 2022, the Board of Supervisors directed staff to enhance the Department of Public Works and Planning - Development Services Code Enforcement Program, and

WHEREAS, the Department of Public Works and Planning - Development Services identified the need for additional staff, vehicles, equipment, and training necessary to implement the enhancement of the Code Enforcement Program, and

WHEREAS, Net County Cost in the amount of \$70,911 are necessary to cover costs associated with the needed aforementioned staff resources for the remainder of FY 2021-22, and

WHEREAS, said funds are not included in the Department of Public Works and Planning - Development Services Org 43600200 FY 2021-22 Adopted Budget; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths (4/5) vote of the Board of Supervisors.

NOW, THEREFORE IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector be authorized to increase the appropriations in the FY 2021-22 Public Works and Planning - Development Services Org 43600200 as follows:
