WHEREAS, said monies are not included in the FY 2021-22 adopted appropriations and estimated revenues of the Department of Social Services Org 5610; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifth vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2021-22 Department of Social Services Org 5610 as follows:
