WHEREAS, the Recommended Budget of the County of Fresno, State of California, for the Fiscal Year 2022-23 ("Recommended Budget") has been prepared, made available for public distribution, and distributed according to law, and

WHEREAS, notice that the Recommended Budget has been so prepared and made available for public distribution, specifying the time and place of the Board of Supervisor's hearing upon the Recommended Budget for the purpose of fixing the Final Budget, has been published on August 31, 2022 in The Business Journal for the time in the manner required by law; and

WHEREAS, a hearing upon the Recommended Budget was held by the Board of Supervisors as described in the published notice of hearing, at which hearing items of the Recommended Budget were considered and discussed and all additions and deletions to the Recommended Budget were made; and

WHEREAS, the hearing having been continued from day to day, as necessary, and there being no requests or applications on file with the Board of Supervisors for further hearing, and the Board of Supervisors having declared said hearing concluded; and

WHEREAS, the Recommended Budget, as adjusted by the Board of Supervisors at the conclusion of the public budget hearings, contains the specific requirements of Government Code section 29089.

NOW, THEREFORE, BE IT RESOLVED, that the Recommended Budget for the County of Fresno for the Fiscal Year 2022-23, as amended during the public hearings on the

1 Recommended Budget, be and is hereby adopted as the Final Budget for the Fiscal year 2022-
2 23 for all funds governed by the Board of Supervisors, which document is adopted by reference,
3 as provided for the Government Code Section 29090, and made a part of this Resolution.

4 BE IT FURTHER RESOLVED that the Auditor-Controller/Treasurer-Tax Collector shall
5 publish the Final Budget, as well as file the Final Budget as provided for in Government Code
6 section 29093.
