**IN THE MATTER OF SUPPORTING THE )**  
**"CLIMB TO KAISER" CYCLING EVENT )**

**WHEREAS**, the non-profit Fresno Cycling Club will hold the 45<sup>th</sup> annual "Climb to Kaiser" cycling event which will involve over 16,000 feet of climbing during the 155-mile route; and

**WHEREAS**, the "Climb to Kaiser" event, previously rated as the one of the ten toughest rides in America by Bicycling magazine, will be held on Saturday, June 17, 2023; and

**WHEREAS**, over 150 cyclists will attempt the Kaiser route which will take riders over such climbs as Burrough Valley Road, Old Tollhouse Road, Huntington Lake Road, and Kaiser Pass Road; and

**WHEREAS**, participants from California and other surrounding states will be supported by almost 200 volunteers during this Fresno County event; and


**WHEREAS**, the Fresno Cycling Club has applied to the State of California to conduct the "Climb to Kaiser" cycling event on State property; and

**WHEREAS**, the "Climb to Kaiser" cycling event may temporarily impede and restrict the free passage of traffic over State Highway Route 168 on Saturday, June 17, 2023, between Clovis and Kaiser Pass between 5:30am and 10:00pm.


**NOW THEREFORE, BE IT RESOLVED** that the Fresno County Board of Supervisors hereby approves and consents to the proposed "Climb to Kaiser" cycling event and recommends approval of and consents to the proposed restrictions of State Highway Route 168 upon terms and conditions deemed appropriate and necessary by the State of California Department of Transportation.
