



2023-24 Fresno County Local Priorities

On an annual basis, the Fresno County Child Care & Development Local Planning Council (LPC) analyzes county child care data (both center- and family/home-based care) from a variety of sources (including the California Department of Education, Central Valley Children's Services Network (Resource and Referral Agency), Fresno Economic Opportunities Commission (EOC) Head Start and Early Head Stars Programs, and American Institutes of Research) to assign a Priority 1, 2, and 3 designation to the zip codes of highest need using both a number and a percentage threshold for our county size (over 200,000 but less than 1 million residents):

- **Priority 1:** Option 1: For Priorities for Infant Toddler Services and Preschool, a zip code qualifies as Priority 1 when there are 40% or more eligible children underserved and there are more than 150 children underserved; and for Priorities for School-Aged Child Development Services zip code qualifies as Priority 1 when there are 40% or more eligible children underserved AND there are more than 200 eligible children underserved.
- **Priority 2:** Option 1: For Priorities for Infant Toddler Services and Preschool, a zip code qualifies as Priority 2 when there are 25% or more of eligible children underserved and there are more than 75 children underserved; and for Priorities for School-Aged Child Development Services a zip code qualifies as Priority 2 when: there are 25% or more of eligible children underserved AND there are more than 100 eligible children underserved
- **Priority 3:** Option 2: All other zip codes in the County.
