WHEREAS, the Probation Department – Grants Fund 0001, Subclass 10000, Org 34322000 will receive funding from the State of California Board of State and Community Corrections in the amount of \$470,000 for the purchase of two new vehicles, as well as necessary equipment and supplies; and

WHEREAS, said monies are not included in the adopted appropriations for the FY 2022-23 and estimated revenues of the Probation Department's Organization 34322000 Grants; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote by the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2022-23 Probation Organization 3432000 Grants as follows:


