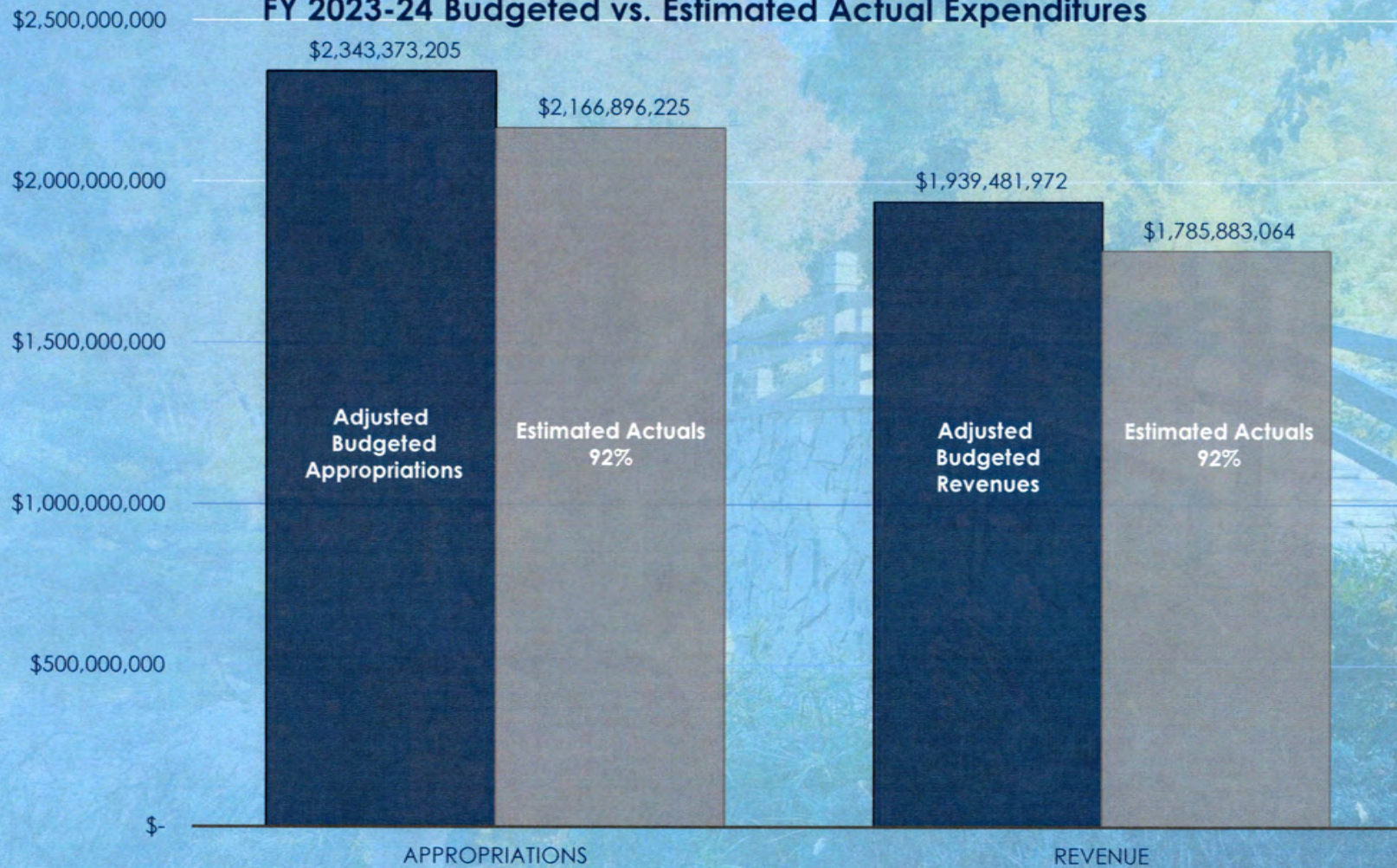

FY 2023-24 MID-YEAR REVIEW

- Most departments indicate meeting their budgeted Net County Cost (NCC).
- Departments estimated to exceed their budgeted NCC are as follows:
 - Sheriff
 - County Clerk – Elections
 - Public Health
 - County Counsel

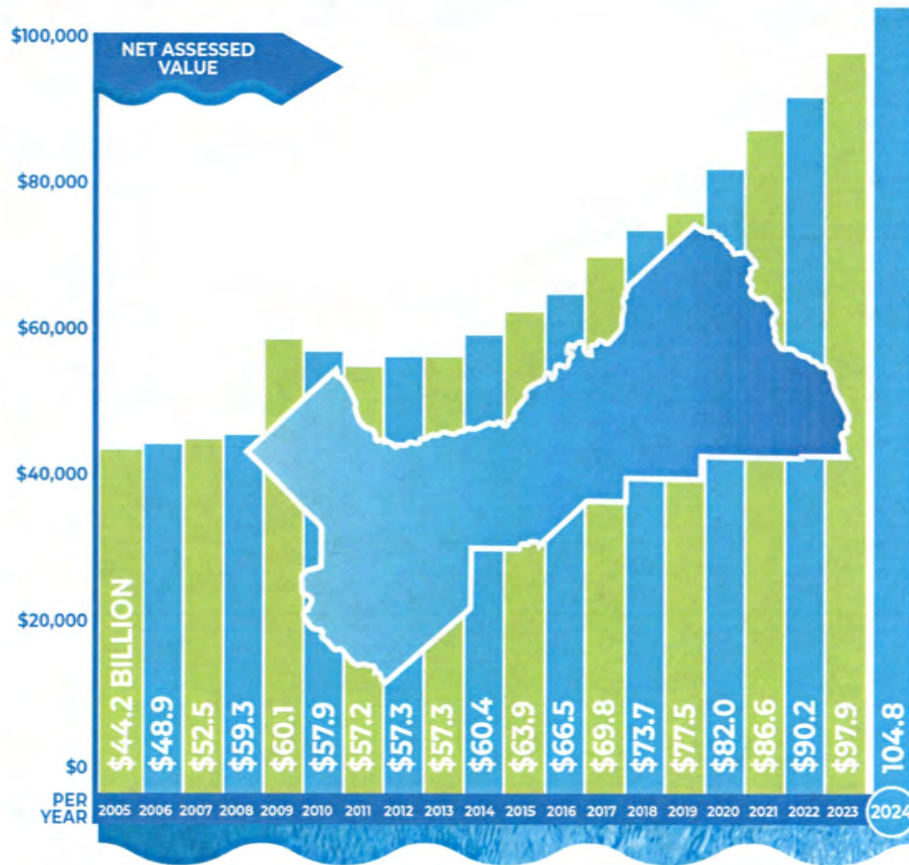
OUTLOOK FOR FY 2024-25

- Countywide Revenues

- Countywide Revenues or *Discretionary Revenues* are significantly impacted by Assessed Value growth.
- A growth factor of approximately **2%** was applied to prior year actual Property Tax for FY 2023-24 budget.
- Continuing this conservative approach to budgeting Discretionary Revenues is recommended.

OUTLOOK FOR FY 2024-25

- Sales Tax Revenues
 - Bradley-Burns Sales Tax
 - Receipts for the first two quarters of FY 2023-24 were 2% less than actuals received in the prior year.
 - Sales tax revenues are expected to be mostly flat for FY 2024-25.

OUTLOOK FOR FY 2024-25

- Expected Operating Cost Increases
 - Salaries & Benefits
 - Negotiated increases
 - Retirement contribution increase
 - Services & Supplies
 - Inflationary cost increases across the board
 - Liability Insurance increase
 - Jail and Juvenile Hall medical services contract increase
 - IHSS negotiations

OUTLOOK FOR FY 2024-25

- State Budget

- The Governor's proposed \$291.5 billion budget included a projected **\$37.9 billion deficit**, proposing a variety of spending reductions, delays, fund shifts, and reversions which could have varying impacts to the County.
- As of late February, the California Legislative Analyst's Office (LAO) estimates the budget deficit to be significantly greater at **\$73 billion.**
- Department of Finance's February Finance Bulletin indicates that cash receipts were \$5.9 billion (4.8%) below the fiscal year-to-date forecast of \$121.5 billion.
