Cedar Avenue, Fresno, CA 93725, APN 331-061-9 10 52, based on violation of Fresno County Ordinance Code ("FCOC") Chap. 10.60, in that 299 marijuana plants were being cultivated on said parcel. 11 This Board further 12 determined that the parcel owner and responsible party is George Finley ("Finley"), and 13 imposed against Finley an administrative penalty in the amount of \$29,900; and 14 WHEREAS, on October 28, 2014, Finley filed a lawsuit titled *George Finley v.* 15 County of Fresho, et al., FCSC Case Nol. 14 CE CG 03222, contesting imposition of the 16 administrative penalty and requesting other forms of relief; and 17 WHEREAS, on May 12, 2015, the Board met in closed session to discuss the Finley suit, and without waiving attorney-client or closed session privilege or work 18 19 product protection as to any other topic of discussion, authorized settlement of the suit, 20 to include withdrawal of the administrative penalty assessed against Finley, in exchange for Finley's agreement to bear his own costs of suit and attorney fees, and to release all 21 known and unknown claims relating in any fashion to the subject matter of the complaint 22 23 in George Finley v. County of Fresno.

NOW, THEREFORE, BE IT RESOLVED as follows: consistent with authority
granted to County Counsel, this Board hereby withdraws the \$29,900 in administrative

1	fines assessed against Finley, conditioned upon Finley's bearing of his own costs of suit
2	and attorney fees, and his release of all known and unknown claims relating in any
3	fashion to the subject matter of the complaint in George Finley v. County of Fresno.
