Narrative

Source:

On 8/12/2015, Sergeant Lucas, Detective Mullis, Deputy Coningsby, Deputy Reyes, Deputy Vincent and I conducted a marijuana cultivation investigation at 3737 N. Del Rey. The marijuana cultivation site had been previously identified during an overflight by Deputy R. Coningsby.

Investigation:

Upon arrival I contacted a male subject, later identified as Sone Sengsiri, inside the residence. I advised Sone I was with the Sheriff's Office and was responding to his address regarding a possible marijuana cultivation site located on the property. I asked Sone if he had any marijuana growing on the property and he stated that he only had peppers growing on the property. I asked Sone if he would show me the garden where the peppers were growing and he said yes. As we were walking toward the rear of the property I again asked Sone if he had marijuana growing on the property and he stated he had 5 marijuana plants growing with the peppers. Sone led me to a garden area where I observed five marijuana plants approximately 3 feet tall growing amongst other vegetable crops. I photographed the marijuana plants where they were growing. Detective Mullis advised me that he believed Narcotics Detectives had been to this same address in 2014 and contacted Sone about a marijuana cultivation site. I asked Sone if he was aware of the county ordinance regarding the cultivation of marijuana and if he had been contacted previously by Detectives. Sone stated he was aware of the county ordinance and retrieved an administrative citation he had been issued in 2014 for 126 marijuana plants. Based on Sone's knowledge of the county ordinance and the prior citation I had the assisting personnel eradicate the 5 marijuana plants growing in the garden. I issued Sone an administrative citation for a violation of Fresno County Ordinance 10.60.060, \$5,000 fine, and left a copy in his possession.


