On 08/12/2015, at about 1222 hours, the Fresno County Narcotics Enforcement Team (FCNET) and assisting personnel conducted a marijuana cultivation investigation at 2746 E. Avenell Ave. (Fresno County). We arrived and contacted Prom Damlong DOB 12/10/1941.

Investigation:

On 02/15/2015, I received information from Dep. Coningsby regarding a marijuana grow. Dep. Coningsby advised that he was flying in the Sheriff helicopter when he observed a greenhouse structure in the backyard 2746 E. Avenell Ave. that contained marijuana. On 03/04/2015, at about 1105 hours, I conducted a marijuana compliance check at 2746 E. Avenell Ave. I arrived and contacted Ken Damlong DOB 01/17/1934 in the side yard. Ken was identified by his California Drivers License.

Ken spoke primarily Lao. I contacted the AT&T translator service and spoke to operator #6964. Operator #6964 translated the English language to Lao. I asked Ken if he lived at the residence. Ken told me that he lives at the residence sometimes. I asked Ken who owned the residence. Ken could not tell me who owned the residence. I asked Ken if he was growing marijuana in the backyard. Ken told me that he and two other subjects were growing marijuana in the backyard. Ken could not tell me who the other subjects were. I asked Ken if he could show me the marijuana plants. Ken agreed and showed me the fenced in backyard. I observed a large greenhouse structure. Inside the greenhouse I observed about 250 marijuana plants in the ground. I asked Ken how many plants belonged to him. Ken estimated that over 100 plants belonged to him. Ken provided me with his medical marijuana recommendation. I observed the card to expire on 05/28/2015.

I explained to Ken that it was illegal to grow marijuana pursuant to Fresno County Ordinance Section 10.60.060 and that he was subject to a \$1,000.00 per plant fine. I explained and issued Ken a 15 day notice of abatement. I took digital photographs of Ken and the scene. On 03/20/2015, Sgt. Lucas confirmed that the marijuana had been removed from the property.

On 08/04/2015 I received information from Dep. Coningsby regarding another outdoor marijuana grow located at 2746 E. Avenell Ave. Dep. Coningsby advised that he was flying as an observer in the Sheriff helicopter when he located about 100 live marijuana plants in the backyard of the above address.

On 08/12/2015, at about 1222 hours, the Fresno County Narcotics Enforcement Team (FCNET) and assisting personnel conducted a marijuana cultivation investigation at 2746 E. Avenell Ave. Upon our arrival I contacted Prom Damlong DOB 12/10/1941 at the front door of the residence. Prom was primarily Lao speaking. I contacted Community Service Officer Khamphou Insyarath via telephone. CSO Insyarath translated from the English language to Lao. Prom told me that she lived at and owned the property. Prom told me that her husband, Ken Damlong, was in Stockton at a funeral. Prom went on to tell me that the marijuana on the property belonged to an unknown subject that lives in Stockton. Prom could not provide me with any contact information for that subject. Prom gave me consent to search the property and a detached garage. I located a door in the interior of the garage that was locked with a pad lock. Posted on the wall next to the interior door were medical marijuana recommendations for Ken and Prom. Prom told me that she did not have a key to the lock and allowed me to cut it off. There were no marijuana plants located in the garage but it was set up for drying and processing marijuana. Behind the residence detectives located 71 live marijuana plants in a fenced in area outside the curtilage of the residence.

A 2012, Drug Enforcement Agency (DEA) yield study, concluded that an average marijuana plant will produce about one pound of dry marijuana bud. Based on the above study, I believe the marijuana plants located at 2746 E. Avenell Ave. would produce about 71 pounds of dry marijuana bud. Based on my training and experience and interviews with persons who use marijuana, typical marijuana use is about 3 to 5 pounds of marijuana per year. This is because on average a user will consume 2 to 4 grams of dry marijuana bud per day, either by smoking or eating edibles cooked with some form of concentrated cannabis. There is enough marijuana being grown at 2746 E. Avenell Ave. for 2 people to have over 7 years' worth of marijuana each. Based on my training and experience and the amount of marijuana located at 2746 E. Avenell Ave., I believe the marijuana is being cultivated as a valuable commodity, intended for illicit commercial purposes and sale.

Based on the medical marijuana recommendations that I located in the garage I believe that Prom not only knew about the marijuana on the property, but was also responsible for it. I advised Prom that she was in violation of Fresno County Ordinance Code section 10.60.060 and subject to a \$1,000.00 per plant fine. I explained and issued Prom a citation for violation of County




