WHEREAS, the County of Fresno, Public Works and Planning – Grants, Tree Mortality 2016 Org 55125200 will receive funding in the amount of \$1,650,000 from the State of California Disaster Assistance Act for the payment of costs related to the removal of drought-killed and dying trees on or along public lands in Fresno County; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues of the FY 2016-17 Public Works & Planning – Grants, Tree Mortality 2016 Org 55125200; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5ths vote by the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in FY 2016-17 Public Works & Planning – Grants, Tree Mortality 2016 Org 55125200 as follows:


