WHEREAS, the Fresno County Public Library will receive a grant in the amount of \$10,000 from Cal Humanities for the "Follow the Flume: Stories of the Lumber Trade that Shaped California's Central Valley" project; and

WHEREAS, said monies are not included in the FY 2016-17 appropriations and estimated revenues of the Library Grants Organization 7517; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2016-17 Library Grants Organization 7517 as follows:






