WHEREAS, the Department of Public Health has additional funds available from the California Department of Public Health, Childhood Lead Poisoning Prevention Program in the amount of \$121,666, and

WHEREAS, said monies were not included in the appropriations and estimated revenues of the FY 2016-17 Department of Public Health, Organization 5620; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5 vote of the Board of Supervisors.

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2016-17 budget of the Department of Public Health, Organization 5620 as follows:




