The public protest hearing will be open to all members of the public. During the hearing, any person may present relevant oral or written testimony to the Board, and the Board will consider all objections or protests to the proposed new water fees. During the hearing, the Board may decide to continue the hearing to a later date without further notice.

If you disagree with the proposed new water fee, you may submit a written protest. The Board will not impose the new water fees if a majority of the County Service Area No. 47 (CSA 47) property owners or tenants submit written protests against the proposal. To be valid and counted, written protests must be <u>received</u> by the Clerk to the Board of Supervisors before the close of the public protest hearing on September 13, 2016.

If there is not a majority protest, the Board may impose the proposed new water fee.

Explanation of the Proposed New Water Service Fee

The current rate structure was passed on August 10, 2010. At that time, there were approximately 571 connections. Since then, CSA 47 has grown to 707 connections, which is the max number of available connections. The proposed new water service fees have been developed to cover the costs for the current operations and maintenance, and administration of the water system. The proposed new water fees were designed to bring revenues into alignment with costs for water service.

The new proposed water fee is comprised of two components, a "base water service fee" and a "water usage fee". The proposed "base water service fee" is calculated by averaging annual costs to 1.) operate, maintain and administer the water distribution facilities and services for CSA 47 over three years, 2.) adjust to account for inflation, and 3.) includes up to 5,000 gallons of water per connection per month. The proposed "water usage fee" is applied to water usage in excess of 5,000 gallons per connection per month, and billed on a bi-monthly basis for water services.

The following tables detail the two components of the water service fee:

Table 1 - New Base Water Service Fee

The <u>first component</u> is a "base water service fee", which includes 5,000 gallons of water per month. The "base water service fee" is accounts for all operations, maintenance and administrative costs needed to maintain the water system over a five year period starting, November 1, 2016.

The <u>second component</u> is the water usage fee, to be charged based on actual monthly water usage for each 1,000 gallons used in excess of 5,000 gallons.

If there is not a majority protest, the Board may impose the proposed sewer fee adjustment.

Explanation of the Proposed Sewer Fee Increase

The current rate structure was passed on August 10, 2010. At that time, there were approximately 571 connections. The district's expenses have increased since the 2010 Prop 218 by an average of 15% year over year, while revenues have increased by an average of 4% year over year. A fee increase is necessary because the current revenues are not sufficient to cover the existing operations and maintenance costs, and the repair of the District's aging sewer system.

The proposed sewer service fee is calculated by averaging annual costs to: 1.) operate, maintain and administer the sewer collection facilities and services for CSA 47 over three years, 2.) adjust to account for inflation, and 3.) build reserves for operations and maintenance, and capital replacement. The Charter School will continue to be billed annually based on the number of registered students, faculty and staff, as determined by the Engineer's Report.

Monthly Sewer Fee For Sewer Services

The average cost of the sewer system operations and maintenance, and administration over three years was analyzed to develop the fee for sewer services. The sewer service fee includes the cost to deliver sewer services, operation and maintenance of the sewer system, for sewage collection and disposal services.

Billing to Quail Lake Elementary School is based on the registered student, faculty and staff count, which the School shall provide to County staff at the beginning of each school year. If County staff do not receive a census by September 30 of each year, Quail Lake Elementary School will be billed for a total population of 598 students, faculty and staff.

The proposed sewer fee includes inflation adjustments of 3.0% annually over a five-year period (effective November 1st of each year beginning on November 1, 2017, with the last adjustment to occur on November 1, 2020).

Additional Information

The proposed sewer fees, if not opposed by a majority of the property owners, and if approved by the Board at the public protest hearing on September 13, 2016, will be implemented on November 1, 2016. Property owners would first see this change on the November/December bill, which they can expect to receive in January 2017.

If the proposed fee increase is not imposed due to a "majority protest," as defined above, then the current fees will remain in effect and County staff will schedule a public community meeting. The purpose of that meeting will be to discuss cost saving strategies to prevent costs from exceeding available revenues.
