In the Matter of: INTENTION TO OFFER MOBILE FOOD) SERVICES LICENSE AGREEMENT FOR UNIVERSITY MEDICAL CENTER PARKING LOT "M"

RESOLUTION OF INTENTION TO OFFER LICENSE AGREEMENT AND AUTHORIZING CLERK TO THE BOARD TO PUBLISH NOTICE OF INTENTION TO OFFER LICENSE AGREEMENT ON COUNTY OWNED AND LEASED PROPERTY

WHEREAS, the County of Fresno (County) owns the property known as University Medical Center and,

WHEREAS, the County is requesting bids for a License to operate Mobile/Portable Food Service Units at University Medical Center, and

FURTHER, persons wishing to bid for the License must comply with the following instructions and terms of the agreement

- 1. The minimum bid shall be \$5,000.00 per year
- 2. All written bids should be delivered to the Clerk to the Board of Supervisors by 10:00 a.m. the day of the auction in a sealed envelope labeled "Bid for UMC" accompanied by a certified or cashier's check in the sum of \$1,000.00 payable to the County of Fresno
- 3. Public Works and Planning staff upon the opening of written bids will ask for oral bids. All oral bidders who have not made a deposit must present a certified or cashier's check in the sum of \$1,000.00 payable to the County of Fresno prior to making an oral bid. The starting oral bid must be at least 5% over the highest written bid accepted.
- 4. All unsuccessful bidders will have their checks returned to them by Public Works and Planning staff upon completion of bidding. The \$1,000.00 deposit by the successful bidder is non-refundable and will be credited to the first year's rent.
- 5. The Board reserves the right to reject any and all bids if it deems it best for

- the public interest. All proceedings for the granting of this license will be conducted in accordance with applicable provisions of the California Government Code.
- 6. In the event the first bidder fails to execute the agreement with the County, the County may later award the bid to the runner-up bidder under the same terms as stated herein or rebid the agreement. Under such an event, the first bidder forfeits the \$1,000.00 deposit and will not be eligible to rebid.
- 7. The license will be an exclusive license to operate mobile portable food service unit, Monday through Friday of each week from 6:00 a.m. to 5:00 p.m., except on County observed holidays.
- Licensee shall be assigned one (1) designated parking space at the
  University Medical Center location (Exhibit A), as specified by the County.
- 9. The license will be for a term of five (5) years commencing on or about January 1, 2017 and ending December 31, 2021.
- 10. The agreement may be terminated immediately for breach of contract and without cause upon thirty (30) days written notice given by the County of Fresno.
- 11. The Licensee shall pay rent in equal monthly installments due the first day of each month and if payment is not made by the 7th of each month, a 10% late penalty fee will be charged.
- 12. The Licensee, including any and all of the Licensee's officers, agents, and employees will at all times be acting and performing as an independent contractor.
- 13. The agreement may be modified from time to time by written consent of all the parties.
- 14. The agreement shall be non-assignable without the consent of the County of Fresno.

- 15. Licensee shall hold the County of Fresno harmless from any costs, damages, liabilities, claims and losses to any person or property arising from the use of the premises.
- 16. Licensee shall maintain Commercial General Liability, Automobile Liability and a policy of Worker's Compensation insurance as required.
- 17. The Licensee shall, at any time as deemed necessary, make available all of its records and data for audit and inspection by the County of Fresno.
- 18. Licensee shall be responsible for trash removal and cleanup.
- 19. Licensee shall only sell food and food related products from mobile/portable food service units and no tables, stands or other methods of vending will be allowed. No general merchandise shall be sold other than those items specifically approved by the County of Fresno.
- 20. Licensee shall provide food service Monday through Friday, except on County observed holidays and hours mutually agreed upon between both parties.
- 21. Venue for any action arising out of or relating to this license agreement shall only be in Fresno County.
- 22. All notices between either party shall be in writing and shall be delivered by registered mail.
- 23. Licensee shall limit access to food service location (Exhibit A) in designated area at the University Medical Center location.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors intends to grant the above-described License in accordance with the provisions of this Resolution;

BE IT FURTHER RESOLVED that bids for the License shall be taken by public auction to be held in the Board of Supervisors' Chambers, Room 301, Hall of Records, 2281 Tulare Street, Fresno, California on October 12, 2016, at the hour of 10:00 a.m.

BE IT FURTHER RESOLVED that notice of the adoption of this resolution and the time and place of opening of bids shall be given by the Clerk to the Board by posting
