- \* Given this undue concentration of licenses, ABC must deny the application unless your Board determines that public convenience or necessity would be served by the issuance
- \* Additionally, there is a moratorium on the issuance of offsale (Type 20) licenses for Fresno County where the ratio of licenses exceeds one for each 2,500 inhabitants.








