3	THIS AGREEMENT is made and entered into this 27th day of <u>September</u> , 2016, by		
4	and between the COUNTY OF FRESNO, a political subdivision of the State of California,("COUNTY")		
5	and the FRESNO COUNTY SUPERINTENDENT OF SCHOOLS, whose address is 1111 Van Ness		
6	Avenue, Fresno, CA 93721 ("FCSS"), for the purpose of continuing the Truancy Intervention Program,		
7	hereinafter referred to as "TIP." TIP is a collaborative effort involving the following school district		
8	entities: the Caruthers, Coalinga-Huron, Firebaugh-Las Deltas, Golden Plains, Kerman, Laton, Mendota,		
9	Sanger, Sierra and Washington Unified School Districts; Washington Colony Elementary School		
10	District; Fresno County Office of Education's Violet Heintz Education Academy; and Kermit Koontz		
11	Education Complex, each of which is hereinafter referred to individually as a "DISTRICT" and		
12	collectively referred to as "DISTRICTS."		
13	<u>WITNESSETH:</u>		
14	WHEREAS, the Fresno County Probation Department (hereinafter "Probation		
15	Department") recognizes the correlation between chronic school absenteeism and criminal activity, drug		
16	use and incarceration, and therefore believes a continued coordinated effort through an anti-truancy		
17	program will reduce school absenteeism; and		
18	WHEREAS, FCSS and the representative DISTRICTS believe that the continued funding		
19	of TIP will help decrease truancy, improve attendance, increase learning opportunities, and raise financial		
20	revenue for school districts throughout Fresno County; and		
21	WHEREAS, FCSS has obtained separate agreements with the representative		
22	DISTRICTS to fund TIP during the 2016-17 fiscal year; and		
23	WHEREAS, FCSS desires the continued coordinated efforts of the Probation Department in		
24	the anti-truancy program; and		
25	WHEREAS, the Probation Department does not have the means to fully fund such a		
26	program.		
27	NOW, THEREFORE, in respect of the mutual promises contained herein, COUNTY and		
28	FCSS hereto agree as follows:

OBLIGATIONS OF FCSS:

1.

2 FCSS shall compensate and remit to COUNTY from the TIP fund, held by FCSS, 3 an amount that will partially fund the services of two (2) Deputy Probation Officers five (5) days per 4 week, not to exceed, in aggregate, the maximum amount payable under this Agreement of One 5 Hundred Thirty-Seven Thousand Four Hundred Fifty-Six and 00/100 Dollars (\$137,456.00). 6 FCSS shall timely facilitate and be responsible for obtaining each DISTRICT's 7 financial contributions to the TIP fund. FCSS shall have and maintain at its place of business a separate 8 Memorandum of Understanding (MOU) with each DISTRICT, regarding that DISTRICT's financial 9 contribution to the TIP fund. FCSS shall also be responsible for the timely transfer of each DISTRICT's 10 financial contribution into the TIP fund. A summary of each DISTRICT's contribution to the TIP fund is 11 set forth in Exhibit "A," attached for reference purposes only. An exemplar of the MOU between FCSS 12 and each DISTRICT is set forth in Exhibit "B," attached hereto for reference purposes only. 13 2. **OBLIGATIONS OF THE COUNTY:** 14 The duties of the assigned Deputy Probation Officers shall include, but are not 15 necessarily limited to, the following: 16 1) The support of the TIP system as developed by the DISTRICTS and the 17 Probation Department; 18 2) Participation in the training of school district personnel regarding the TIP 19 procedure and instruction in meeting the legal requirements of compulsory 20 education; 21 3) Participation in school site meetings with the parents/guardians of students who 22 have been identified as chronic absentees to notify them of the TIP program, 23 attendance laws, legal sanctions, key school contact personnel, and family support 24 agencies; 25 4) Participation in the school's SARB meetings with parents/guardians when 26 possible; 27 5) Meetings and follow up with students and parents/guardians regarding compliance 28 with SARB recommendations;

1	6) Participation in the mid-year and year-end meetings with all TIP participants		
2	regarding program status and recommendations for improvement;		
3	7) Responding to calls from TIP participants regarding specific problems or		
4	questions;		
5	8) To act as needed in cooperation with the school directives regarding truants;		
6	9) To assist schools in supervising identified chronic truants; and		
7	10) To make home visits, accompanied by a DISTRICT employee, to families with		
8	children who are at risk of truancy.		
9	3. <u>TERM</u> :		
10	This Agreement shall become effective on July 1, 2016, and shall terminate on June		
11	30, 2017, unless sooner terminated as provided in this Agreement.		
12	4. <u>TERMINATION</u> :		
13	A. <u>Without Cause</u> – Either COUNTY or FCSS may terminate this Agreement		
14	without cause upon the giving of at least thirty (30) days advance written notice of such termination to the		
15	other party.		
16	B. Breach of Contract – Either COUNTY or FCSS may immediately suspend or		
17	terminate this Agreement in whole or in part where in the determination of either party there is:		
18	1) An illegal or improper use of funds;		
19	2) A failure to comply with any term of this Agreement; or		
20	3) A substantially incorrect or incomplete report has been submitted.		
21	The aggrieved party shall give written notice of such termination to the breaching		
22	party. In no event shall continued provision of services by COUNTY constitute a waiver by		
23	COUNTY of any breach of this Agreement or any default that may then exist on the part of FCSS.		
24	Neither shall continued provision of services by COUNTY to FCSS impair or prejudice any remedy		
25	available to COUNTY with respect to the breach or default.		
26	Upon any termination of this Agreement, COUNTY shall be compensated for all		
27	services provided to FCSS, up to and including the date of termination based upon a prorated amount:		
28	<i>i.e.</i> the total financial obligation of FCSS to COUNTY under this Agreement, as prorated, based upon

1 the period of time this Agreement is in effect, compared to the total one (1) year term provided 2 hereunder.

5. COMPENSATION / INVOICING:

4 As compensation to COUNTY for the performance of its services under this 5 Agreement, FCSS agrees to pay COUNTY and COUNTY agrees to receive compensation from the 6 TIP fund on or after the dates of October 30, 2016, and January 1, April 1 and July 1, 2017, 7 respectively, that amount indicated in the billing of the Probation Department to FCSS for those dates 8 as set forth in this paragraph; however, not to exceed in aggregate the maximum amount payable 9 under this Agreement of One Hundred Thirty-Seven Thousand Four Hundred Fifty-Six and 00/100 10 Dollars (\$137,456.00). COUNTY shall invoice FCSS as noted in this section, addressed to: Fresno County Office of Education, Attention: TIP, 1111 Van Ness Avenue, Fresno, CA 93721. Payments 12 by FCSS shall be made within (45) days of invoice for services provided by COUNTY.

6. INDEPENDENT CONTRACTOR:

In performance of the work, duties and obligations assumed by COUNTY under this Agreement, it is mutually understood and agreed that COUNTY, including the two (2) assigned Deputy Probation Officers, will at all times be acting and performing as an independent contractor, and shall be an employee of COUNTY and not an employee or agent of FCSS. Furthermore, FCSS shall have no right to control, supervise or direct the manner or method by which COUNTY shall perform its work and function. However, FCSS shall retain the right to administer this Agreement so as to verify that COUNTY is performing its obligations in accordance with the terms and conditions thereof.

FCSS and COUNTY shall comply with all applicable provisions of law and the rules 22 and regulations, if any, of governmental authorities having jurisdiction over matters the subject thereof.

7. MODIFICATION:

Any modifications to this Agreement requested either by COUNTY or FCSS may only be effected if mutually agreed upon in writing by duly authorized representatives of the parties hereto without affecting the remainder of this Agreement. This Agreement shall not be modified or any rights of it waived except by such a writing.

8. NON-ASSIGNMENT:

Neither COUNTY nor FCSS may assign, transfer or subcontract their obligations 2 under this Agreement or any rights hereunder without the prior written consent of the other party.

9. NO THIRD PARTY BENEFICIARIES

Nothing express or implied in the terms and conditions of this Agreement is intended to confer, nor shall anything herein confer, upon any person or entity other than COUNTY or FCSS and their respective successors or assignees, any rights, remedies, or obligations or liabilities whatsoever.

10. HOLD HARMLESS:

COUNTY agrees to indemnify, save, hold harmless, and, at FCSS's request, defend FCSS, their officers, agents and employees from all claims, losses, judgments, and expenses, including attorney fees and costs, occurring, resulting, or arising from the negligent or wrongful performance by COUNTY or its officers, employees, or agents, of obligations agreed to be performed by COUNTY under this Agreement.

FCSS agrees to indemnify, save, hold harmless, and, at COUNTY's request, defend COUNTY, its officers, agents, and employees from all claims, losses, judgments, and expenses, including attorney fees and costs, occurring, resulting, or arising from the negligent or wrongful performance by FCSS or its officers, employees, or agents, of obligations agreed to be performed by FCSS under this Agreement.

11. INSURANCE:

Without limiting COUNTY's right to obtain indemnification from FCSS or any third parties, FCSS, at its sole expense, shall maintain in full force and affect the following insurance policies or a program of self-insurance, including, but not limited to, an insurance pooling arrangement or Joint Powers Agreement throughout the term of this Agreement. Coverage by FCSS shall be provided for General Liability and Worker's Compensation. Upon request from COUNTY, FCSS shall provide a certificate of insurance or self-insurance providing evidence of such coverage.

25 Without limiting FCSS's right to obtain indemnification from COUNTY or any 26 third parties, COUNTY, at its sole expense, shall maintain in full force and effect the following 27 insurance policies or a program of self-insurance, including, but not limited to, an insurance pooling 28 arrangement or Joint Powers Agreement throughout the term of this Agreement. Coverage by

COUNTY shall be provided for General Liability and Worker's Compensation. Upon request from

6	examination all of its records and data with respect to the matters covered by this Agreement. COUNTY		
7	shall, upon request by FCSS, permit FCSS to audit and inspect all of such records and data necessary to		
8	ensure COUNTY's compliance with the terms of this Agreement.		
9	If this Agreement exceeds Ten Thousand Dollars (\$10,000.00), COUNTY shall be		
10	subject to the examination and audit of the Auditor General for a period of three (3) years after final		
11	payment under contract (Government Code Section 8546.7).		
12	13. <u>NOTICES</u> :		
13	The persons and their addresses having authority to give and receive notices under this		
14	Agreement include the following:

27	15. ENTIRE AGREEMENT:

- E. Golden Plains Unified School District shall contribute $\frac{6,469.37}{5}$;
- F. Kerman Unified School District shall contribute \$ <u>16,305.01;</u>
- G. Laton Unified School District shall contribute <u>\$2,469.30;</u>
- H. Mendota Unified School District shall contribute \$ 9,887.17;
- I. Sanger Unified School District shall contribute \$ <u>37,922.18;</u>
- J. Sierra Unified School District shall contribute <u>\$ 3,500.00;</u>

- L. Washington Unified School District shall contribute <u>\$ 8,969.86</u>.

MEMORANDUM OF UNDERSTANDING

BETWEEN THE FRESNO COUNTY SUPERINTENDENT OF SCHOOLS

AND_____SCHOOL DISTRICT

This Agreement is made and entered into by and between the Fresno County Superintendent of Schools ("FCSS") and ______ School District ("DISTRICT"), hereinafter referred to as "the Parties." The purpose of this Agreement is to fund the Truancy Intervention Program ("TIP"), a collaborative for addressing chronic absenteeism in Fresno County Schools. TIP shall provide for a coordinated multi-agency effort involving the Fresno County Office of Education; representative Fresno County school districts; and the Fresno County Probation Department ("COUNTY").

Services that shall be provided for the schools participating in TIP are included in the Master Agreement, attached hereto, for purposes of review by the DISTRICT.

THEREFORE, in respect of the mutual promises contained herein, the Parties agree as follows:

OBLIGATIONS OF THE FCSS

FCSS shall compensate and remit to COUNTY from the TIP fund to be held in the County School Service Fund, as provided herein, an amount equal to the cost of two (2) Deputy Probation Officers five (5) days per week, not to exceed, in aggregate, the maximum amount payable under this Agreement of One Hundred Thirty-Seven Thousand Four Hundred Fifty-Six Dollars and 00/100 (\$137,456.00).

FCSS, or its designee, shall act as the central facilitator in the TIP program. FCSS shall have the power to terminate the Master Agreement for any reason as specified in the Master Agreement, and thereby release DISTRICT from this MOU from the date of termination of the Master Agreement.

OBLIGATIONS OF THE DISTRICT

DISTRICT shall contribute _____ Dollars (\$____), which is DISTRICT'S portion of the cost of the TIP program.

FCSS shall invoice DISTRICT on a quarterly basis for actual cost of service as billed by Fresno County, and DISTRICT shall pay the fee within thirty (30) days of such invoice. Should DISTRICT payment not be made within thirty (30) days of said invoice, payment will be by automatic transfer approved by the FCSS from DISTRICT'S General Fund account to the TIP fund held in the County School Service Fund.

DISTRICT shall communicate to the FCSS any act as described in Section 4 of the Master Agreement that may be cause for termination of the Master Agreement. If FCSS terminates Master Agreement, DISTRICT shall contribute its prorated share of its contribution amount up to and including the date of termination.

<u>TERM</u>

This Agreement shall become effective on the 1st day of July 2016, and terminate on the 30th day of June, 2017.

This Agreement constitutes the entire agreement between FCSS and DISTRICT and supersedes all previous understandings regarding this Agreement.
