The Library is requesting Wi-Fi services to be purchased for 34 branches. The service should include equipment needed, installation, filtering, internet service., Wi-Fi service and support.

Term of the Agreement is from October 1, 2016 through September 30, 2018 for a total cost of \$180,753.24.
4. Identify the unique qualities and/or capabilities of the service(s) and/or product(s) that qualify this as a Suspension of Competition acquisition.  
X-Act Technology has the filtering capabilities a Library needs for content provided for public use. Vendor also has made the service a one-stop shop in which they will work with the utility companies necessary in each area to contract for internet services. X-Act also credits each branch account for internet services in communities where the utilities company gives the Library free internet service.

6. Explain why the unique qualities and/or capabilities described above are essential to your department.  
Although there are various Wi-Fi service providers in the market, X-Act is able to best meet the need of a Library with 34 distinct and sometimes remote locations throughout the County. Before the end of the Agreement term, the Library researched other potential vendors to compile a bid list for a Request for Proposal. Through this process, the Library was unable to find another local vendor that currently meets the needs of the Library for Wi-Fi and internet protection measures. A Request for Proposal was not necessary since there is only one viable vendor. The Library has internet protection measure needs with respect to the access that can be offered for public use, be it adults or children. X-Act is also the current provider for 34 Library branches and the equipment and installation in those branches are already in place therefore the only new equipment and installation expenses for this agreement would be for an upgrade of 20 internet access points.
7. Provide a comprehensive explanation of the research done to verify that the recommended vendor is the only vendor with the unique qualities and/or capabilities stated above. Include a list of all other vendors contacted, what they were asked, and their responses.  
Seven other vendors were contacted to ask if they could provide the Wi-Fi services the Library sought in all branches throughout Fresno County.

  2. CTS Computer Technology Solutions Inc. was contacted, but they were not responsive with services they provided and therefore considered a no quote.
  3. BCT Consulting, Inc. was contacted, but they were not responsive with the services they provided and therefore considered a no quote.
  4. Integrity Networks was contacted, but they were not responsive with the services they provided and therefore considered a no quote.
  5. Valley Network Solutions was contacted, but they did not have the ability or is not currently established to provide the special Filtering services needed.

6. EMD Networking Services, Inc. was contacted, but they did not have the ability or is not currently established to provide the special Filtering services needed.
7. PC solutions was contacted, but they were not responsive with the services they provided and therefore considered a no quote.
